A key result of the Paris Agreement negotiations was the establishment of an enhanced transparency framework for tracking and reporting the progress of existing and future country commitments, with built-in flexibility included for developing country Parties. For this reason, the Capacity-building Initiative for Transparency (CBIT) was created at the request of Parties to help strengthen the institutional and technical capacities of developing countries to meet the enhanced transparency requirements defined in Article 13 of the Paris Agreement.

The CBIT has three aims:

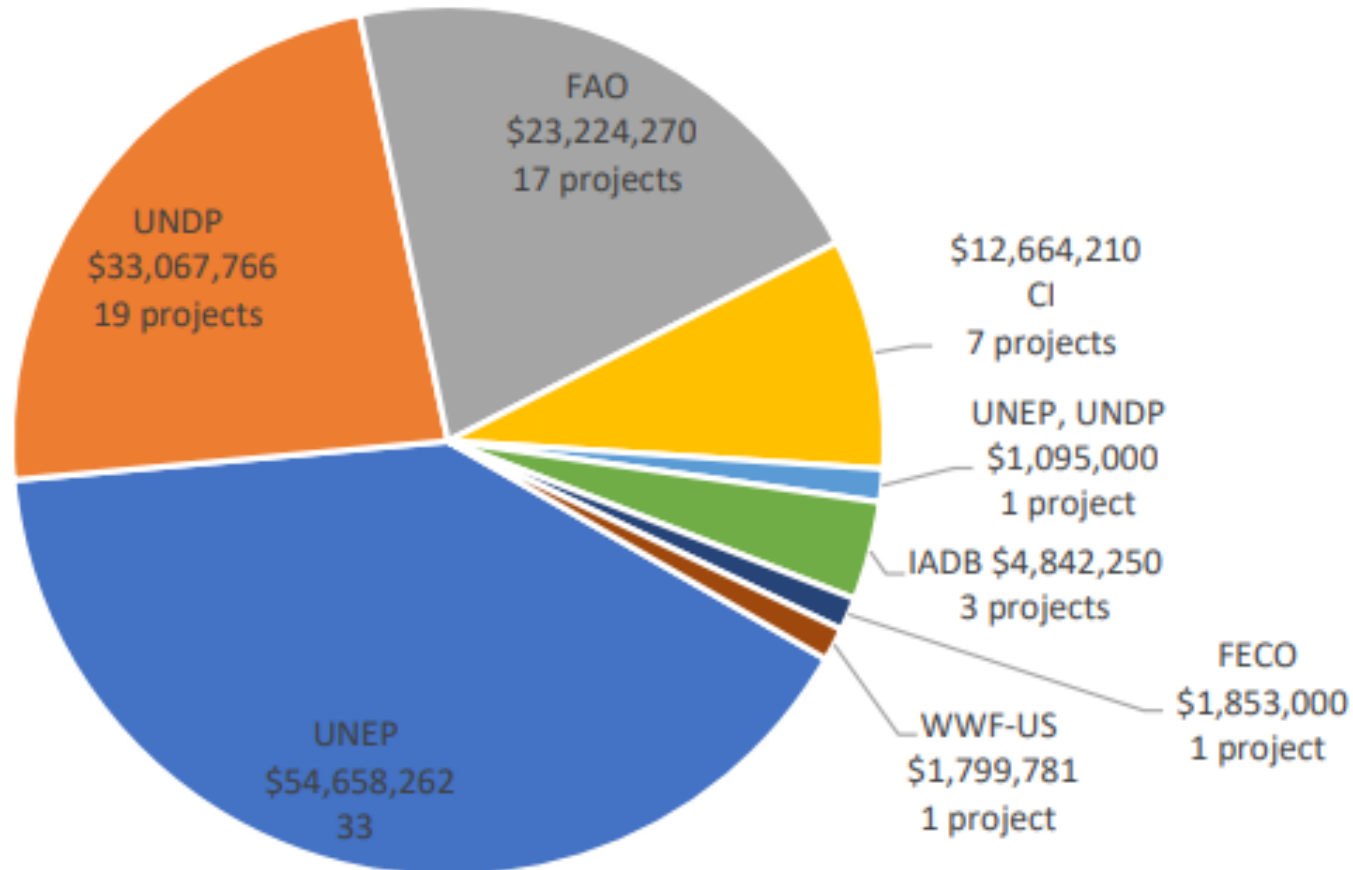
- **Strengthen national institutions** for transparency-related activities in line with national priorities;
- Provide relevant **tools, training**, and **assistance** for meeting the provisions stipulated in Article 13 of the Agreement;
- Assist in the **improvement of transparency** over time.

Overview of CBIT



CBIT Agencies

The CBIT project portfolio as of October 31, 2022 provides support to 82 individual country projects. CBIT projects are implemented by seven out of the eighteen GEF Agencies.



- United Nations Environment Programme (UNEP) - 33 projects
- United Nations Development Programme (UNDP) - 19 projects
- Food and Agriculture Organization (FAO) - 17 projects
- Conservation International (CI) - 7
- Inter-American Development Bank (IADB) - 3
- Foreign Economic Cooperation Center Office, Ministry of Environmental Protection of China (FECO) – 1 project
- World Wildlife Fund (WWF-US) - 1 project
