

### **Objective of the Climate Transparency Platform**

#### Provide countries and support providers with a one-stop shop for climate transparency

#### 1 - Transparency

#### project information

Ongoing and upcoming in-country, regional and global initiatives through a project database.

#### 3 - Transparency

#### resources

A library of practices, methodologies and guidance, including Paris Rulebook and CGE.

#### 5 - Platform for

#### requesting support

A platform and forum for requesting assistance with country reports and transparency issues



### 2 - Transparency country information

Profiles with information on progress on NCs and BURs, selfassessed needs, and CBIT projects.

#### 4 - Interactive userdriven forum

Information exchange and online tools for peer learning, coordination for regional MRV and transparency networks.



### Stakeholder Consultations for the Platform

During Q2 2022, 5 consultations held with transparency experts, country & project focal points, and international agencies & initiatives


**Objective:**

- Agree on national transparency information relevant to feature in country pages





- Shared responsibility among all to keep it updated and useful for everyone



## Content Editors from Agencies on the Climate Transparency Platform






### User Role: Agency Focal Point

(GEF IA)

- Each Agency/Organisation can have multiple Agency Focal Points to share the load of updating
- Agency Focal Points can update the Agency page as well as upload News, Events and **Opportunities**
- Agency Focal Points also have access to their respective projects, e.g., CBIT and EA projects

#### Background

CBIT GSP

- Prior Project: "CBIT Global Coordination Platform"
- Project Objective (new Platform): To provide global streamlined support, capacity building and coordination to help developing countries meet enhanced transparency requirements under Article 13 of the Paris Agreement.
- **Project Output:** 2.3 Coordination among support providers facilitated





#### **Need for Enhanced Coordination**

- Various support providers for transparency exist
- Call from countries for better coordination among support providers
- Various channels exist for requesting support, with countries requesting the same support from different support providers
- Better use of limited resources → better support to countries

etc.

•  $\rightarrow$  Coordination is difficult but is worthwhile
