### Background

The CBIT-GSP is a global capacity-building project funded by the Global Environment Facility, implemented by UNEP, and executed by the UNEP Copenhagen Climate Centre. Its goal is to support countries in transitioning towards the Enhanced Transparency Framework (ETF). A key element of the project is to strengthen knowledge-sharing and peer-to-peer exchange among countries and transparency projects, such as through these webinars.

In response to a request from the Ministry of Environment of Djibouti to the CBIT-GSP project to share best practices from National CBIT projects implemented in MENA, a virtual webinar titled “Inspiring Djibouti’s CBIT Journey: Experience sharing on the implementation of CBIT projects from Tunisia, Morocco and Lebanon” is organized on Tuesday, July 6th, 2024, at 11:30 AM GMT (14:30 Djibouti Time).

By hearing from these countries' experiences, Djibouti will gain valuable perspectives on best practices and lessons learned for enhancing its Climate Transparency Framework.
