









# Ask the expert how to improve your BTR

## **Background**

With the launch of the strengthened transparency framework of the Paris Agreement, all countries must submit their first biennial transparency report (BRT) by December 2024.

The transition to BTRs and MPGs implies increasing the quantity, detail, and rigor of information to be submitted by developing countries. For this reason, many countries are working to internalize the new requirements for a timely, transparent, and quality reporting to the UNFCCC and to meet the deadline for submission of the first BTR. The new reporting format is more demanding in terms of comprehensiveness and details and with that is very challenging for developing countries preparing their first BTR.

The CBIT-GSP project supports developing countries in this important process by bringing international experts together to answer questions on the key reporting areas of the BTR. On October 2<sup>nd</sup>, the first "Ask the expert how to improve your BTR" webinar will answer questions collected across the 10 global Networks, with a particular focus on the NDC Tracking chapter of the BTR. In addition to it, the CBIT-GSP project will introduce a direct communication channel within the *Community of Practice* section on the Climate Transparency Platform, where countries will have the opportunity to continue the discussion on previous questions and to post new ones.
