

#### Biennial Update Report submissions from Non-Annex I Parties.

Non-Annex I Parties, consistent with their capabilities and the level of support provided for reporting, should submit their first BUR by December 2014, and every two years thereafter. The least developed country Parties and small island developing States may submit BURs at their own discretion. The BURs shall be prepared in accordance with the guidelines contained in decision 2/CP.17 (decision 2/CP17).

The BURs shall be submitted using the National Reports C<sup>3</sup>Submission Portal (NRSP) C<sup>3</sup>. Please note that the file name should not contain the special characters while uploading the submission to the NRSP. Questions relating to the use of the submission portal should be addressed to reporting-nai@unfccc.int.

There is an increasing trend in the submission of NIRs and Technical Annex on REDD+ in conjunction to the BURs. The status of such submission are presented in the table below.

# The final BURs by developing countries shall be those that are submitted no later than 31 December 2024 (1/CP.24, para. 38). This implies that a developing country Party may submit their final BUR prior to 2024.

The Parties of the Convention that are not Parties under the Paris Agreement will continue reporting BR/BURs as appropriate.

### First Biennial Transparency Reports.

Parties to the Paris Agreement shall submit their first Biennial Transparency Report (BTR) @ and National Inventory Report (NIR), if submitted as a stand-alone report, in accordance with the modalities, procedures and guidelines (MPGs), at the latest by 31 December 2024. The least developed country Parties (LDCs) and small island developing States (SIDS) may submit the information referred to in Article 13, paragraphs 7, 8, 9 and 10, of the Paris Agreement at their discretion. Once submitted, the BTR will undergo a technical expert review @ process. A facilitative, multilateral consideration of progress @ will also be conducted for each Party.

#### Reporting, review and multilateral consideration

The table below includes Party submissions of First Biennial Transparency Reports (BTR1) and National Inventory Reports (NIR), if submitted as a stand-alone report; and other annexes to the BTR. The NIR consists of a National Inventory Document (NID) and the Common Reporting Tables (CRT). Technical expert review reports and summary reports of FMCP sessions are also published as they become available.


