





In-person training on reporting obligations on Climate Adaptation and Climate Finance

Date: 29-30 April 2025 **Place:** Tirana, Albania **Modality:** In person

To support the Contracting Parties (CPs) of the Energy Community in fulfilling their reporting obligations under the adapted Governance Regulation (GovReg), the European Environment Agency (EEA) provides technical assistance through the "Supporting Energy and Climate Monitoring by the Energy Community" Project. At the same time, the Capacity-building Initiative for Transparency – Global Support Programme (CBIT-GSP) is providing support and capacity-building at the national, regional, and global levels to help developing countries meet the reporting requirements of the UNFCCC and the Paris Agreement's Enhanced Transparency Framework, ultimately increasing ambition for climate action.

By March 15, 2025, the CPs should have met their reporting requirements on climate change adaptation under two dataflows: Art 19 – National climate change adaptation strategies and planning, and Art 17 – Decarbonisation (Adaptation): progress to target. Reporting on climate finance is also required in 2025, including the dataflow on Use of revenue from carbon pricing mechanisms and the newly introduced Financial and technology support provided to developing countries. These reports are due by the end of July 2025 and September 2025, respectively, and must be submitted through the EEA's reporting platform, Reportnet.

Additionally, in the context of the UNFCCC Biennial Transparency Report (BTR) reporting, countries should report on their climate adaptation actions as captured by their Adaptation Communication or a chapter on climate adaptation within their BTR. This also includes the reporting on *Financial and technology support provided to developing countries* (for reporting under the GovReg) and reporting on *Information on financial support needed and received by developing countries* (specific to UNFCCC requirements).

In response to these obligations, the EEA, in collaboration with the Energy Community Secretariat and in partnership with the Capacity-building Initiative for Transparency – Global Support Programme (CBIT-GSP), is hosting a training workshop in Tirana, Albania from 29-30 April 2025.

The workshop aims to equip CPs/Eurasian countries with the necessary knowledge to:

- Better understand what needs to be reported under the climate adaptation and climate finance reporting requirements of the GovReg and UNFCCC BTR
- Exchange on how to gather the data, experience in reporting and on inter-institutional coordination
- Understand the quality review processes under both reporting streams
- Explore how the related data are used at the national, EU, and global levels

The workshop will focus on practical experiences from countries and involved institutions to enhance learning and application.
