Responding to country-specific vulnerabilities and climate impacts to address short-mid-and long-term needs.



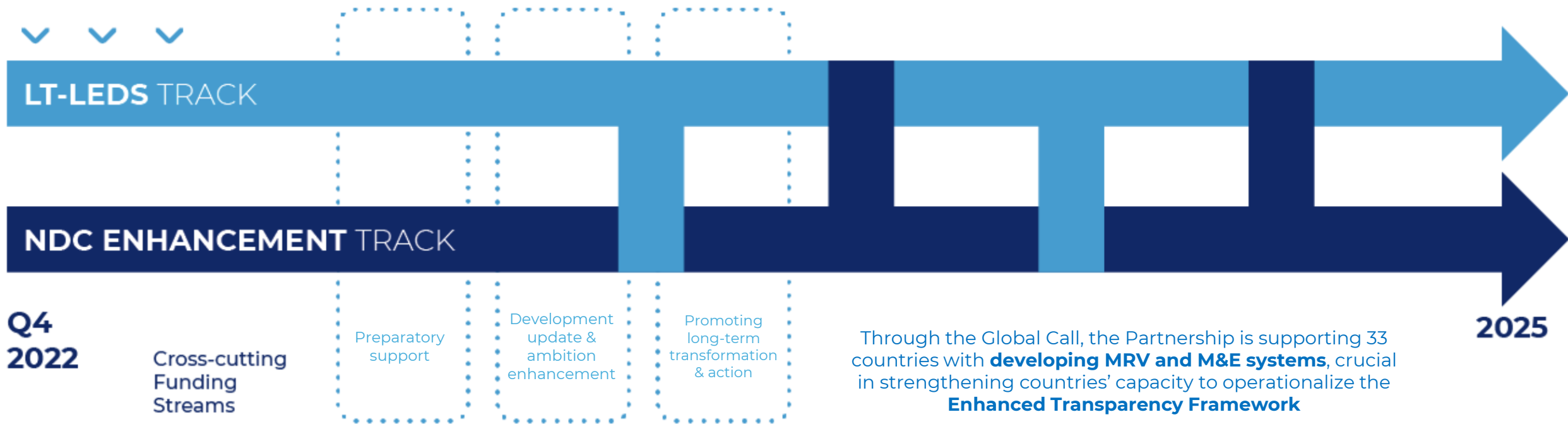

Kazakhstan	Developing draft strategies to relevant chapters and sections of Kazakhstan's NDC 3.0 on: (i) loss and damage, (ii) adaptation, (iii) financing, and (iv) agriculture through a consultative process involving experts and stakeholders, and with provisions to provide more transparency in reporting and reviewing of relevant data.	ADPC, funded through Partnership Action Fund
Cambodia	Strengthening capacities for technical assessments to update the NDC and track progress towards achieving the updated NDC goals while ensuring transparency and accountability in implementation.	UNDP
Kyrgyzstan	Enhancing municipal-level mitigation, adaptation, and transparency measures in the NDC 3.0 aligned with national targets and local priorities while strengthening provisions to boost private sector engagement, investment, and innovation.	World Bank
Laos	Delivering capacity building on climate modelling, GHG projection, and transparency reporting procedure , as part of an overall assessment of the country's capacity and governance mechanisms to improve and strengthen national policy, institutional and financial frameworks, technical capacities, and other enabling mechanisms to help achieve NDC and LT-LEDS commitments. Tonga	Reviewing, updating, and aligning LT-LEDS and NDC, including developing enhanced reporting and accountability mechanisms in line with the Enhanced Transparency Framework.	GGGI, funded by PAF
Tajikistan	Developing a monitoring and evaluation framework to track progress towards achieving the updated NDC goals and ensure transparency and accountability in implementation.	Seeking support
Bhutan	Enhance the technical capacities of national and regional environment officers to effectively update, coordinate, track, and monitor climate activities. This includes training on NDC, NAP, LT-LEDS, gender and social assessments, as well as developing BTR, National Communications , and other Paris Agreement reporting requirements.	Seeking support
Iraq	Designing and establishing a national MRV system that meets the ETF requirements.	Seeking support
Morocco	Operationalization of the national GHG inventory system and compilation of sectoral inventories to feed the 1st and next Biennial Transparency Report and national communications.	Seeking support

LEVERAGING BTRs TO SUPPORT NDCs

- > While the LTS and NDCs are **ex-ante** (forward-looking), consisting of projections and strategies, BTRs are **ex-post** (backwards-looking).
- > BTRs **bridge the gap between commitments and action**, ensuring that NDCs are not just promises but measurable and trackable efforts toward climate goals.
- > Aligning the BTR approach with NDC development allows for:
 - > Enhanced technical capacity
 - > More accurate projections
 - > Clearer policy impact
 - > More efficient resource allocation
 - > Strengthening reporting and transparency
