

## Introduction

Belize, a country highly vulnerable to the impacts of climate change, is taking bold steps to strengthen its resilience through the development of a National Loss and Damage Framework and a forward-looking Cost of Inaction Study. This initiative, supported by UNDP under the Climate Promise Programme, aims to equip national institutions with the tools, data, and strategies needed to assess climate-related losses and guide evidence-based policy and investment decisions. The missions and technical engagements outlined in this presentation mark a critical foundation for building long-term climate resilience in Belize.

## Implementation plan

#### **Step 1: Project Initiation**

Start Date: February 1, 2025 Establish agreement between UNDP's Climate Promise and Regional Hub for Latin America and the Caribbean, Panama. Define scope, deliverables, and timeline

#### Step 2: Mission 1 – Exploratory Mission (Feb 3–7, 2025)

Conduct stakeholder engagement and bilateral meetings. Identify priority sectors and climate hazards. Map existing data and institutional capacities. Set up a national technical working group. Draft a detailed workplan and governance mechanism.

#### Step 3: Inception Report (by Feb 28, 2025)


Finalize methodology and sector prioritization. Outline stakeholder engagement and capacity-building strategy. Submit for review by NCCO and UNDP.

#### Step 4: Mission 2 – Technical Mission (June 1- 4, 2025)

Conduct country mission visit and validate assumptions. Collect final data for the Cost of Inaction study. Engage sectoral experts and refine analytical models.

#### Step 5: Cost of Inaction Study (by August, 2025)

- •Analyze potential future losses under various climate scenarios.
- •Provide evidence for policy and investment decisions.
- •Quantify economic and non-economic impacts in key sectors.



Step 6: Mission 3 – Validation & Awareness (August-September, 2025)

•Present draft results to stakeholders. •Conduct a 2-day workshop with decision-makers. •Raise awareness and gather feedback.

#### Step 7: Loss and Damage Framework (by September, 2025)

•Develop a national framework for L&D data collection and management. •Define institutional roles, data protocols, and response mechanisms. •Align with international standards (e.g., UNFCCC/WIM).

#### Step 8: Final Report & Roadmap (by October, 2025)

- •Integrate findings from the study and framework.
- Submit final deliverables to NCCO and UNDP.
