- Even though the information was here revised a lot of times, much more work has to be done. **Key to enhance and validate the classification of data**

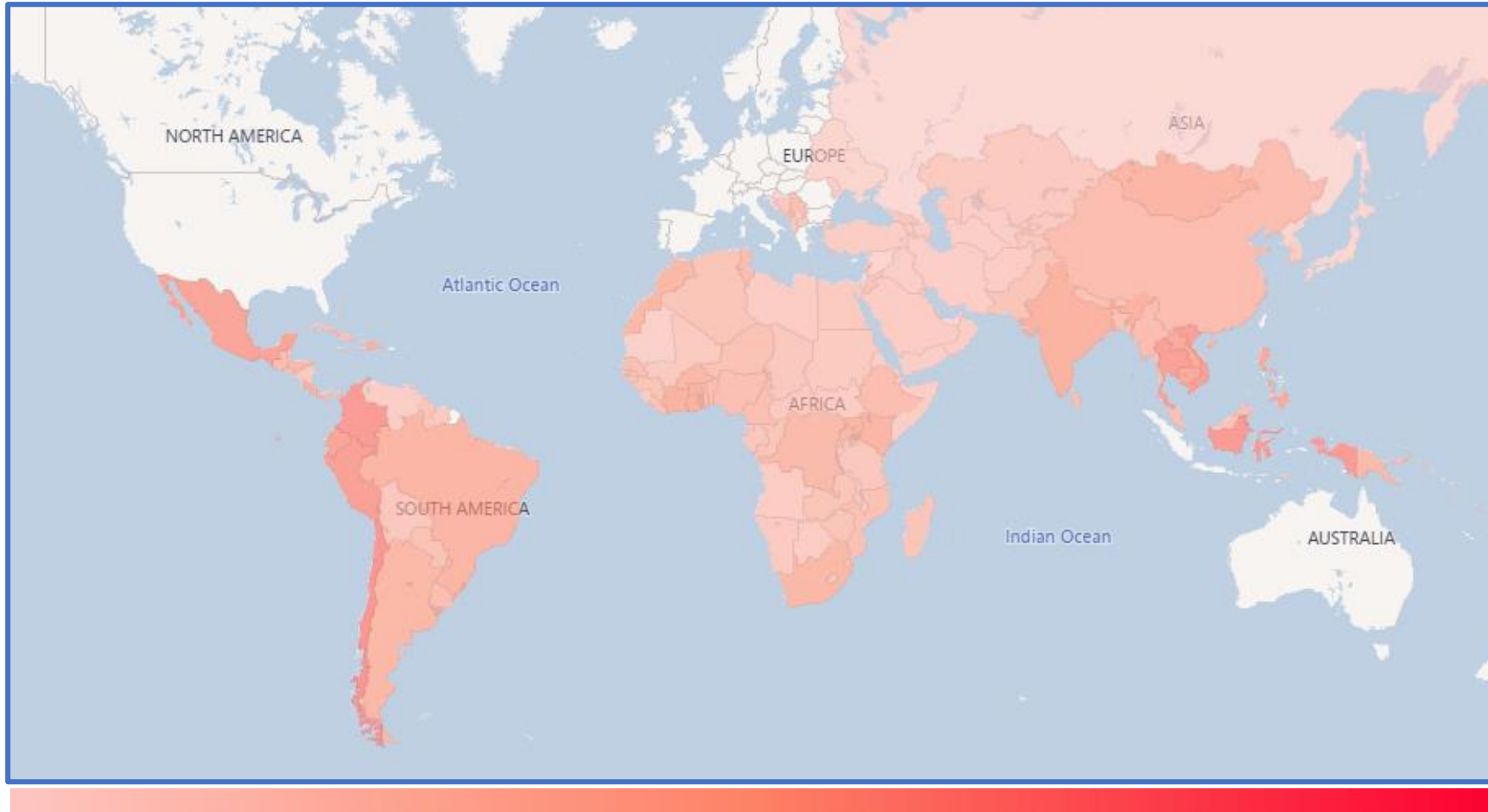

Some final thoughts (1)



- i. In some cases, there is a correlation between support received and results achieved (e.g. Chile), in some others there is not (e.g. Philippines)
- ii. How to measure “achievement”? is BUR submission a good proxy? *A starting point for the next presentation*
- iii. Do following initiatives build up on previous ones or some duplications exist? Do support providers discuss among each others on this before starting an initiative in a new country?
- iv. Some regions attract less interest than others, for example Middle East and Central Asia. Is this an issue?
- v. Out of the scope of this effort: NDC implementation – how is the support provision there linked with the one on transparency?

Some final thoughts (2)



- This has been a massive effort to gather and compile information but it should and could improve over time
- **Can this data provide valuable inputs in decision making?**
- To continue this initiative it is essential to have an active and reliable person willing to provide data every 6 months – **is there appetite for this?**
- If yes to both questions:
 - importance of having a compiler (a focal point to gather and provide info) in each organization
 - UNDP willing to facilitate the gathering and drafting of such data report, twice a year, before the meetings of the Group of Friends.
- More friends, more complete information – encourage a more participatory approach from organizations who have not provided yet updated info
- Is this data sensitive? How should it be managed?
