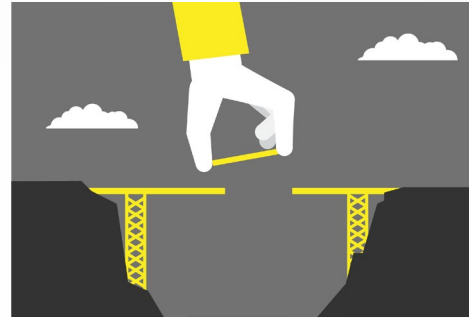

# The Paris Committee on Capacity-building aims

*“... to address **gaps and needs**, both current and emerging, in implementing **capacity-building** in developing country Parties and further enhance capacity-building efforts, including with regard to **coherence and coordination** in capacity-building activities under the Convention.”*

(1/CP.21, paragraph 71)



# Work plan

- ▶ The PCCB has been tasked with overseeing and managing the **2016-2020 capacity-building workplan** launched by COP 21
- ▶ Based on its aim and mandates, the PCCB adopted a **rolling work plan for the period 2017-2019**;
- ▶ Implemented through the lens of the PCCB's annual focus area or theme (2017-2019 focus area: **Capacity-building activities for the implementation of NDCs**);
- ▶ Supported through **four thematic PCCB working groups** focused on:
