The CBIT Global Coordination Platform (or short 'CBIT GCP') hosts all CBIT projects worldwide and brings together practitioners from countries and agencies in order to:

- Enable coordination
- Identify needs and gaps in national transparency systems
- Share lessons learned through regional and global meetings
- Facilitate access to emerging practices, methodologies, and guidance on transparency of climate action and support
- Support the community of practitioners working on CBIT projects
- Facilitate the sharing of good practices from CBIT countries

What can the CBIT GCP offer a CBIT Project?

The CBIT Global Coordination Platform offers a space for each CBIT project (the project page), providing the country with a communication tool for domestic and international audiences on the focus and the progress of implementation of its CBIT project. The project page allows the country to effectively communicate the progress of the project, and also share results such as deliverables or events. It allows provides tools for assessing the capacity-building needs on climate transparency, and an effective way to communicate these.

As a focal point to the CBIT project of your country, you have access to a customized area of the platform like the one in the image below. You will only see this area after you are registered as focal point and [logged in](#). We also need to link your profile to the project, so let us know if there are issues, and we address those.

This customized area shows a list of shortcuts that allow you to perform different tasks.

My Profile: Change your profile information, including password, add a photo and a bio.

My country's projects: View and edit the information in the project page, including the status of implementation of activities, add information about project events, add project documents.

My documents: Shows all the documents you have uploaded to the platform, and allows you to add documents to appear in the library or in the project page.

My events: Shows all the events you have created in the platform, and allows you to add events to appear in the project page.

My recommended documents: Shows publications relevant to you, based on the capacity gaps identified by the self-assessment tool.

Self-assessment tools: Gives you access to a tool, developed by the CBIT GCP, which assesses the capacity-building needs on climate transparency of the country.

Other support initiatives in my country: Enables you to add information about other projects or initiatives in your country that are supporting the development of capacities in climate transparency in the country.

In addition, you can:

Your Role as the Focal Point of a CBIT Project

As the Focal Point of a CBIT Project, you play an important role on the CBIT Global Coordination Platform. It is your responsibility to keep the page of your CBIT project up-to-date and we therefore recommend you to visit the page of your CBIT project **quarterly** to make sure the information in there is updated. This allows other CBIT projects and agencies and even stakeholders from your own country to follow the progress of your CBIT project. Particularly the following elements should be updated regularly:
